It is costing the association monies to have the garbage taken to the dump and when we did the budget, we did not allocate any funds for this.

Have had some calls about dead fish on the beach area. This is from Mother Nature, we have no control, but we do have cleanup on the beach area 3 times a week. Sorry if this caused any inconvenience. I just would like to update everyone on homeowner Association dues.

# Thank you everyone for his or her dues payment. We appreciate you paying in a timely matter.

As of July 31, 2013, we have 17 unpaid liens on file (25 LOTS). That comes out to \$1320.00 of unpaid dues. 2011 we have (6 lots) unpaid and 2012 we have (15 lots) unpaid. The total for the 3 years is \$2428.00

This does not include interest and court fees. Liens have been placed on the homes until they pay the outstanding balance. Notices were sent out before the liens were placed. If anyone owes any Assoc. dues/back dues please call me (Val) 708-420-4218 and we can talk and make arrangements of payments.

Our dues are\$ 52.80 per lot per year that comes out to .14465 cents a day. Other associations have a much larger fee. Our dues are to go for the upkeep on the lakefront.

- 1. Installation and removal of the piers
- 2. Keep swim area and beach clean
- 3. Maintaining Lakefront's lawn and controlling poison ivy
- 4. Pay INSURANCE for everyone's protection.
- 5. Pay electric bills
- 6. Provide port-a-potty for lakefront use
- 7. Pavilion and water pump upkeep
- 8. TAXES


