## 2015 ANNUAL DUES

We would like to take this opportunity to thank those who have already sent in their annual dues for the 2015 season. If you have not paid your dues yet, you may do so by mailing them to **Lakewood POA, PO Box 371, Adams Wi 53910**. Please remember that payment is due by Saturday, May 2, 2015. This year's dues remain at \$52.80 per lot. Dues paid after June 2, 2015 will have a lien placed on the property at the homeowner's expense. Your timely payment enables the association to continue with improvements as well as the upkeep of our beautiful lakefront.

1 lot = \$52.80, 2 lots = \$105.60, 3 lots = \$158.40, 4 lots = \$211.20, 5 lots = \$264.00.

## 2015 BEACH PASSES



Beach passes will again be of the hang tag variety this year. Upon receiving full payment of your 2015 dues, we will send you two (2) beach passes per homeowner (not per lot). We are asking you to be vigilant about displaying your hang tags from your rearview mirror each time you are at the lakefront.

Please dispose of your 2014 hang tags as they will no longer be valid after May 2.

Thanks again to everyone who visibly displayed their tags throughout the 2014 season. This is OUR lakefront, beach, playground and pavilion. If we work together, we can protect what we all pay for.

## DON'T GET TOWED...DISPLAY YOUR HANG TAG!

Starting in 2014, we partnered with Harper Salvage in Adams in order to monitor our lakefront and ensure that we are keeping non-members off Lakewood property. Harper installed signage around our parking areas and warnings were given out to vehicles in violation of displaying hang tags from rearview mirrors. Going forward, we will have to assume that a vehicle without a hang tag is a non-

member and that vehicle will be towed at the owner's expense. PLEASE be sure that you and your guests are displaying a hang tag every time you visit the lakefront. It may be necessary to "car pool" to the lakefront if the two hang tags you receive are not enough to cover all the vehicles in your party. We realize the tags are not the perfect solution and look forward to a date in the near future when we will be able to

install the electric gate. Thanks to all, in advance, for making the best of this situation.
