Our annual meeting was in May and I was again elected to the Board. In discussion with Dave he asked to step back to the Vice President chair and I would take the President chair. For those of you who don't know me, I have been on the board for the past 6 years. 3 years as a Trustee and then on the Board. Burt and I have had our home here for the past 24 years. We have always been involved in one way or another and love this place very much. I hope to continue the vision Dave had and make the Lakefront more enjoyable for all of you. Suggestions are always welcome. My phone number is on the front page and I have added my email address. Please feel free to use both. You may also notice that Judy Sachs is not active as Secretary. She will be doing some traveling and has indicated she will be here to help but would like to stay in the background. She has given more than 10 years to the Association and we would like to thank her for all the time and effort she put forth for our group.

Some items to discuss. The 4th of July picnic is scheduled for July 2nd. Registration will start around 11:00am and food serving around the noon hour. When registering please pay your dues if you haven't, and you will get your new beach passes. We have a new procedure this year; you will get your passes when you pay your dues. Passes will no longer be sent through the mail as too many of them have been lost and misplaced in the past. The festivities really begin on Friday night at 7:00p with the lively music from the New Arkdale Ramblers. Ice cream and good fellowship will be available in good abundance. Bring a chair for your comfort. Remember to get your reservation for the picnic to Ruth no later than June 27th so we are able to order chicken and side salads. Bring a favorite recipe dish to pass for the group. We also welcome sweets for the sweet tooth in all of us.

NOTE: you will not be able to launch your boat on Saturday July 2nd between 10:00am to 4:00pm. Trailers will not be allowed in the parking area. This is for personal vehicles only on this day. If you want to bring your boat down to the water you are able to launch from the Strongs Prairie launch in the cove just to north of our beach. Please have your beach pass in the vehicle so we know that you are a member of the Association.

We are also asking for some parents to volunteer to help with the children games. If your child is participating in a game, please consider working with them for the length of the game. This is only a few minutes out of your family time and you will have that extra fun with the little ones. All games will have prizes for the winners and even the runners up will have a gift for their efforts. We also will have our annual horse shoe tournament, so start getting your team together. Prizes will be awarded for 1st and 2nd place winners.

Due to the high water levels at the lake we have been unable to have the piers installed. Please be patient, we are doing our best. The pier people advise it is unsafe for them to install with water levels this high and even if they could get them in the water, they would be submerged. If you really feel the need to launch your boat, go around to the Strongs Prairie launch. They have piers permanently in and it is easy to launch from there. It is in the cove just to the north of our beachfront.



LAKEWOOD HOMEOWNERS ASSOCIATION ANNUAL MEETING MAY 7, 2011

The Annual Meeting was called to order at 10:30 M. There were 38 persons present and we had a quorum. Ruth Mendelson gave welcoming remarks. David Cohen, our President, was not present as he was still in Florida. The head table consisted of Valerie Exner, Treasurer, Ruth Mendelson Vice President and Judy Sachs Secretary.

Judy Sachs read the minutes to last year are meeting 2010. Mac McGuire made a motion to accept the minutes as read. It was seconded by Jim Walsh. It was accepted by all the homeowners present.

Valerie Exner gave her Treasurer's report. This year we start with \$124.75. We took monies from 2010 and 2011 to take care of the repairs of the lakefront.

Jim Walsh recommended that we send out Newsletters via email and not send them out in the post office. Only send them out to persons who do have use the computer. This should save money in our treasury. In order to use the emails instead of the post office, we all have to have the same programs in order to receive the information and not have any problems opening up the Newsletter. Ruth Mendelson said we had 22 advertisers, and in years past we had up to 38 advertisers. Valerie Exner suggested we can send out a test text to see if everyone was encrypted. It was also suggested to put a note in the Newsletters if they want their newsletter via emails.

Judy Hampson discussed the advertisers. Most of our advertisers want to come back. W will try to increase our advertising.

Valerie Exner talked about the 2011-2012 budget. We still have 2010 dues that are still outstanding. We need to collect them right away. There are fees and interest if we put liens on the houses.

One homeowner, Alan Field, talked about the playground equipment. He felt we should look into new equipment, and maybe commercial equipment. That is what our dues should be paying for.

Norm Hampson talked about locking the gate for the winter. We had discussions about locking up the gate either with a key or with a combination lock. Mac McGuire discussed who comes to the lakefront who are not homeowners.

Ruth asked for more fencing around the lakefront. Right now there is not enough money. That would help deter the non-homeowners from trying to come in with ATV's and snowmobiles. Others discussed always locking the gate year round, and other homeowners wanted it only in wintertime and just post an address to go to, to have the gate opened for them. The majority want the gates locked from December 1 through March 1. Mac McGuire wants us to have the local homeowners right next door to us to

"keep watch" on the lakefront. We will ask them. Also make sure we take care of all trespassers. Jim Walsh made a motion to close and lock gate at the lakefront from 12/1 to 3/1. It was seconded by Mac McGuire. It was approved by all.

Some of the events for this year are: playground equipment, and lakefront cleanup at least 3 times per week coming up. We will appraise the playground equipment and see what it needs. Debris needs to be cleaned up from the winter. We need to call Hadley Piers and have the piers put in as soon as possible.

We have 2 picnics per year which is the 4th of July picnic and Labor Day picnic. The majority of the homeowners still wants the picnics and will help with them. The Homeowners were asked to vote if they still wanted the Labor Day picnic. They said yes.

Ruth Mendelson's position on the board is up and Ruth was up for re-election. Ruth asked for nominations from the floor before the count. There were no nominations. Jerry and Sally Albers counted the proxies. Jerry Albers read the tally and Ruth received 69 votes and Paul Kelly was a write-in. Ruth is re-elected to the Board for another three years.

There will be an open Board Meeting at the home of Ruth Mendelson at 1:30 PM at 1704 19th Court. Please come to this board meeting as the board would like your input.

Jim Walsh made a motion to adjourn the meeting. Mike Fountain seconded the motion. It was approved and the meeting was adjourned at 11:40 AM.


