

NOTICE FROM SECY/TREASURER

The LIBN lady had to do her duty during the week of June 10. Unfortunately, about 10 property owners received notice of a lien being filed. There are still about 30 owners who have yet to pay their 1991 dues. Since I will be spending some time at our cabin during the first two weeks of July - PLEASE - consider paying your dues immediately and if you do have a lien filed, perhaps you could consider contacting us in order to get your records and ours straight.

Quite a few property owners wrote letters commenting on the reason for the \$30.00 and what was the big deal about it. Well, so far we have installed a new pier for \$3700.00, cleared the beach and fixed the access road for \$400.00, maintained the beachfront area for approximately \$70.00 a month, paid our insurance bills which amount to about \$2000.00, paid our lawyer and the Bergman bills in order to get the north half property deed problem cleared up (about \$3500.00) and we still have the back taxes on this parcel to pay. \$30.00 seems so small an amount but if every owner (of which there are 275 +) would pay for each of their lots we would have almost \$9000.00 a year! We have only collected 60% of that so far.

There is still so much more we would like to do for the Lakewood Properties. We already know that the boat ramp may cost \$2000.00 to \$5000.00 to redo and the beach area will cost around \$4000.00 to make it look nice. In order to have toilet facilities at the beach ant lakefront property to be secured and controlled for members only may cost several thousand more! Every little bit helps!! So if you are reading this newsletter and have not paid your \$30.00, please do so. (Editors note — Danute has work hard and done a good job for Lakewood Property Owner's Assc. while taking only actual expenses incurred instead of the \$200.00 a month authorized at the 1990 meeting. We owe her our gratitude and cooperation. THANKS.... Danute Krebs

PRESIDENTS CORNER

As of this writing, the Judgements against the north half of the lakefront property have been paid by us. This finalizes our agreement with Mr Bergman other than his portion of the back taxes he has agreed to pay. Mr. Bergman indicated to me we will be receiving title to this property before the end of this month. The title will be sent to our attorney, and upon receipt he will be filing at the Adams County courthouse. When we have received title to the property, we will have to pay the back taxes and collect Mr Bergman's portion. Once this is taken care of, this matter will be history and our annual meetings should be about an hour shorter and much more pleasant.

After these events have occurred, it is our intention to secure title insurance, have the entire lake front area surveyed and have our liability insurance extended to cover this north half parcel of the lakefront. We will then start to make short and long range plans for development of the entire lakefront area.

We ask that any members that have ideas for the lakefront property development please submit your suggestions in writing so they can be coordinated with other members thoughts to provide a creative plan that all property owners will be pleased with. We hope this is the beginning of a beautiful lakefront park that we and our children can be proud of and can enjoy for many years to come.

TICKS FOR PBTS does not sound like it would be a good seller. I brought my pit bull out in the woods for a walk in the wild. Chicago is the wildest environment she knows. She sniffed and wandered around looking like a blood hound. When we came into the house some ten minutes later I checked her over. Sure enough there was this small round bug with little legs on each side and a smaller little round head moving across my dogs short white hair. A tick dropped from the tree or jumped from someplace and was now looking for a home in a piece of fresh skin.

How does a person remove a tick? First of all, remember that a tick secretes an enzyme from its mouth to help it dissolve the skin and make it easier for it to burrow into the skin. This sticky secretion also enables the tick to hold on to its new found host. Knowing this makes it easier to remove the tick. Because the tick holds on by its head; you will want to pull it out or off by its head or as close to the head as possible.. If you pull it with tweezers by the round body you will pull the body apart and leave the head under or on the skin. Trying to burn the tick in order to make it back out is a quarantee that you will only burn yourself and the bug's butt real seriously. If you extract the head and the sticky poze, then you got it all. Keep the insect in a little bottle in case you find yourself getting sick. Two to six weeks will bring out the Lyme disease. The doctor can identify the tick and determine proper treatment and a prognosis.

Look for muscle aches, chills and fatigue that resemble flu symptoms. There will also be a round rash around the tick bite. Ticks like both animals and humans. They will drop from trees or jump to you. Ticks are not just a pain for your pets, but for you and the kids too. Be cautious and wise.

From New York city to Seattle Washington; from Los Angeles to the Florida Keys, one thing is common: Vandalism. Not only the cities, but the secluded places where man tries to find solitude have been invaded by the vandals ant thieves. There are a few things about these people we need to know. By knowing their ways, we have a better chance to discourage them.

- 1. A thief is sneaky and Nervous.
- 2. A thief does not want to be found out or noticed.
- 3. A thief feels protected by the embrace of darkness because his or her deeds are evil.

Use a vandals own feelings against him.

A Thief is sneaky and nervous. This attitude and mind set makes them overly cautious and littery. They will not be obvious; they will sneak around to an area that is hidden from plain view. A thief is nervous because they know that they are wrong and don't want to be found out. This attitude makes them littery. What happens when a sneaky, littery, nervous person is suddenly confronted? They become spooked, excited and afraid. That is why they usually strike at night in an area they have cased to be sure it is relatively deserted.

If a thief feels threatened or exposed, he or she will usually not risk being caught or identified. This is where you can take control. If a light suddenly comes on or an alarm or voice sounds, it will usually abort their attack.

There are some clever gadgets you can purchase and install to help discourage thieves and vandals. Designing and installing these can be an adventure in creativity. Following are some ways to protect your property.

One inexpensive device which can be used is a motion sensor. These may be connected to either a light, an audio alarm or both. It can also serve as an entry light when you come home since it will respond as well to your motion as to that of a vandal or burglar. These can be set to turn off after a few seconds or minutes. A sign warning that property is equipped with alarms may also discourage these people. They are wary enough about being found out that they prefer to find a place they are sure is not protected instead of one that may be.

These units can be obtained from Radio Shack, Sears, Sam's Warehouse Club, J. C. Penny and probably many other department and electronic stores. Prices vary with features, degree of sophistication and available discounts. The Heath Co. has a catalogue that list many devices. Their number is 1-800-44-heath. These devices can be put at entrance doors or windows and by stringing some wire underground may be placed at driveway entrances.

Another helpful tip to discourage vandals or other outsiders is to note license numbers of cars you think do not belong and contact the local sheriff at 608-339-3304. They can tell you if it is a local. Sheriff Farber and Peurling both will be helpful.

Other tips are to make your house look occupied by having lights and radios on timers. Have someone stop by and cut a patch of grass or keep a used car in the driveway. (ed note. make sure car is properly registered so it will not be mistaken by the authorities or bad guys as an abandoned vehicle.) There is no absolute protection that is guaranteed to prevent trouble, but some of these things may be of value to some property owners.
