THE PRESIDENTS CORNER

I hope that you and your family have enjoyed the summer at Lakewood, as we have. It's hard to believe that summer is almost over again. Some items that have come to my attention and need to be addressed regarding the Lakefront Area are as follows

- 1. When using your vehicle to bring your beach equipment to the beach area by way of the boat ramp, please unload your vehicle and repark it in the designated parking area. The boat ramp is NOT a designated parking area. Please do this as a common courtesy to residents that wish to use the ramp to launch their boat.
- 2. We have an area designated for vehicles with boat trailers. Please,- after you launch your boat, park your vehicle and trailer in the area designated for this purpose. Once again, this is common courtesy to your neighbors who wish to park in the single vehicle parking area.
- 3. If you bring a pet to the beach, it must remain on a leash. If your pet makes a mess on the beach or in the park area, please clean it up. The reasons for this should be obvious.
- 4. If you or your party create a mess or have garbage and debris lying around, please clean and pick up before leaving. Pleas take your trash and garbage to the dump. Our Lakefront Park is NOT a Garbage Dump.

We have many people using the Lakefront over the summer. We need your help and cooperation in keeping it reasonably neat. At one count there were 60 plus people using the Lakefront facilities at one time. With everyone cooperating, it can be kept in good order and be a pleasure to all members.

One further note on the Lakefront. The unfortunate accident over Memorial Day may have been caused by an act of vandalism. Pleas call the Adams County Sheriff if you witness vandalism at our Lakefront or any Lakewood Property.

Mr Tom Walsh is hired by the Board of Directors to maintain the Lakefront Park & Beach Area. If he asks that you move your vehicle or leash your pet, please comply. He is representing all Lakewood Owners in trying to make our common area more enjoyable. He is requested to report to the Adams County Sheriff any acts of vandalism or disturbances on the beach. He also is instructed to take license numbers and report any unauthorized dumping at the Lakefront Park.

I wrote a letter to Woodland Farms Real Estate regarding reports that they were promising buyers lake access through our property. This was a result of confusion with the Town of Quincy Access area across the bay from us. They have agreed to issue a memo to their sales people to make this distinction clear and telling them that our area is private for use of Lakewood owners only.

I also wrote a letter to the Adams County Sheriff to inquire about the possibility of hiring off duty deputies for extra patrols of our area. I have as yet received no answer to this inquiry. Once again, I hope you all had a happy summer.

IMPORTANT DUES NOTICE

Many owners have not yet paid their 1993-94 association dues and a few have not paid earlier years. If you owe prior years, there are probably interest charges plus lien removal fees also due. Keep in mind that if we are forced to place a lien against your property, all fees plus interest and fees must be paid for you to again have an unencumbered title to sell the property, or for whatever reason you want it. As secretary, I am instructed by the board to place liens when dues are 60 days past due. I have held off as long as I could on this, but must now start filing liens against ALL properties with outstanding dues. All dues were due 30 days after the May 1st meeting and were thus 60 days past due as of August 1, 1993. It is unfair to those who do pay to permit some owners to ignore this obligation.

A little more dock space will of course help to ease the need to do this, but I have seen boats on the beach when the dock was empty. Please try to extend to other owners the same courtesies you would expect from them and remind your neighbors to do likewise. Let us use this Lakefront Park of OURS in a spirit of cooperation instead of confrontation!! Be Happy and Enjoy.

At last board meeting we decided to raise the dues to \$40.00 Per year, and to leave the dues fixed at this rate as long as we can meet our expenses and make small improvements at the lake front each year. This seems to be what the majority of property owners want. We currently have \$10,000.00 in CD's ,4,700.00 in a money market and 5,000.00 in our check book. We have been quite conservative with our money and will continue to do so. To protect the interests of you, the property owners, and our interests at the lakefront we must maintain a positive cash reserve.

We will be sending a ballot out soon, for you to vote on. The issue is weather we should fence off the access to the lakefront to limit access to non-property owners on the south side. You will have to sign this for or against with your lot number or numbers. While the board does not have to have the property owners permission to do this, we feel that this is the best approach. If this is a concern of yours please respond when you receive this ballot. The results will be in the next edition of lakewood. Your fears about entering yourself will not be a problem. We hope to get the boat lanch dredged next year, perhaps add another light, and make some other improvements.
