it does not, property owners would be responsible for the difference. My concern is our risk of liability increases if a non-property owner is involved rather than a property owner.

At our annual meeting a motion was introduced to limit access to the lakefront with a fence and part time people to check those entering. This motion which I felt was the best alternative was defeated. Stickers for cars is difficult. There are many people who do not bring their car to the lakefront. Many invited guests use the property with owners permission. These facts would make car stickers difficult to enforce. We are open and would welcome alternate solutions that would be financially feasable.
