Association fees of \$52.80 per lot are due at the meeting or no later than June 1, 2014. After that the process of putting a lien on your property


will start at your expense. So please pay your dues on time to avoid a lien.



New Signs, Beach Passes, and Towing at the Beach Front

Beach passes will be hang tags for your rear view mirror. Please make sure that the pass can be seen and displayed every time you are at the common area.

We want to make sure that our common area is being enjoyed by **only** our homeowners. We want our beach, playground, and pavilion areas to be an enjoyable, clean, and safe place for all homeowners.

Our new signs have arrived and will be put up soon. These signs will clearly state that this is private property

In an effort to keep the common area for only Lakewood homeowners, additional signs will be added by Harper Salvage Company. Any vehicle that is parked in the common area without a current Lakewood Properties Owners Association issued beach pass, will be towed at the owner's expense.

We will try to give warnings for first time offenders instead of being towed. Please help keep our area for only our homeowners. Hang your beach pass clearly from your rear view mirror every time you are at our lakefront.

6th Amendment to our Declaration of Covenants and Restrictions

This past January paperwork for the 6th Amendment to our Declaration of Covenants and Restrictions was filled and recorded with the Register of Deeds for Adams County.

There are two important amendments that homeowners need to be aware of.

NOW THEREFORE, pursuant to Article 7.2 (a) of the Declaration, Article III of said Declaration is hereby amended to include the following:

- 3.3 <u>No Mobile Homes.</u> No mobile homes shall be used as a permanent residence.
- 3.4 <u>No Abandoned Vehicles.</u> No abandoned motor vehicle shall be permitted to be kept upon any lot subject to these declarations. Said vehicle shall be deemed to be abandoned if it is unlicensed for a period of at least 30 days and remains unlicensed on said lot for a total of at least 30 days within any 365 day period.

Please add this to your By-Laws and Declaration of Covenants and Restrictions.
